Week in Review 02/13/2018

The weekly meeting of the Rotary Club of Pensacola was held at New World Landing on Tuesday, February 13, 2018. Members and guests were greeted at the door with a warm handshake and welcome by Ellis Bullock Jr.. Ticket sales were done by Charles Beall and Frank Beall. They did a great job with a total prize of \$66.00. Innes Richards was the lucky winner this week. Past President Ray Jones opened the meeting with the four-way test. President Paul Tobin, still recuperating, was in attendance and received a hearty welcome. We look forward to his return to the podium and those great history moments. Chris Kelly led us in Prayer and Pledge. Sunshine was presented by Owen Drey, who actually delivered some funny and political jokes. Owen Drey led us in singing Happy Birthday to our fellow Rotarians and introduced our military guests ENS Austin Vanarsdall & ENS Matt Theisen.

Past President Ray Jones then turned the podium over to Mark Harden, who introduced our Guest speaker, Christian Garman of the Innovation Institute at the University of West Florida. Christian spoke on their IDEA Method, Incubate, Design, Experience, and Act which is their platform for innovation.

The Incubate stage starts with a deep dive

into issues of performance, culture or new directions in order to frame a design challenge and determine an initial direction. Human values are at the heart of our collaborative approach. They start in the field to uncover real human needs and perspectives to be addressed. Their collaboration methods will vary by project, sometimes hosting large meetings and "ideation" sessions, other times, smaller gatherings. This process allows teams to begin the process to re-imagine solutions in new and different ways serving as the foundation for initial design and testing of new processes or products for the organization.

In the Design stage, they take the results from ideation and field discussions along with collaborative ideas, theories, concepts and values to build out prototypes into the "Minimum Viable Product" (MVP). These MVP prototypes are then used in early field tests with intended users, as we begin refining toward a solution. This process taken from lean manufacturing allows for early testing with minimal investment in any new product development. It is a great way to prove a concept as the right or wrong direction toward solution building.

In the Experience stage, they implement the refined and expanded prototype into a working

field environment - determining what is working well, what is not and what is ready for further build out. Then they monitor results, make refinements and test again. They run through as many cycles as possible as the prototype is refined.

In the Act state, they are now ready to implement re-imagined ideas and tested solutions throughout the organization. They collaborate through implementation, monitoring any issues along the way and continue to enhance, tweak and fine-tune the outcome for success.

Lastly Christian addressed their work. The Innovation Institute works closely with staff and faculty at the University of West Florida as well as with K12, higher education, corporate, non-profit and government-sector organizations. Through the incubation of ideas, testing and launching new products, processes and services they are able to focus on solving major challenges while generating new approaches, best practices and methods to move the needle in areas where new thinking can produce remarkable change.

Past President Ray Jones thanked everyone for assisting with today's meeting and adjourned the meeting.
