The Gulf Coast Kids House offers a variety of services to help children of abuse. They have law enforcement officers to take the report, members from the Department of Children and Family Services, a child protection team, staff from the State's Attorney's office, counseling services from Lutheran Services, support from Family Advocates, and education and prevention services provided by Prevention Coordinators. All of these services are offered in one location and are designed to make it easier for the children. The facility is child friendly. They are having a fund raiser on March 30th called "Chocolate Fest". Donations of cash, diapers new or gently used clothing, and baby wipes are always welcome. They would welcome new volunteers.

President Betty closed the meeting by thanking our speaker and all of the volunteers who helped with today's meeting.
