Ed Wonders introduced the guest speaker - Ramsey Lawrence of

### Embrace Florida Kids. Here are some highlights:

- Ms. Lawrence is the Development Director for Embrace Florida Kids, an organization created to solve the issue of there being more children who need foster care than there are licensed homes available. Embrace Florida Kids stands in the gap for those children through its Milton Girls Home and Embrace Foster Care Program. However, Embrace Florida Kids has four main programs, outlined below.
- "Embrace Foster Care" is a team that recruits, trains, licenses, and supports foster parents in Northwest Florida, providing a variety of resources that prepare and equip foster families for success. They also screen calls for foster parents to ensure that the calls for assistance that reach the parents are calls that fit the criteria of those parents and do not otherwise disturb parents who might not be able to assist.
- The "Milton Girls Home" is a home that offers a safe haven for teen girls who have experienced trauma. They serve these young women by offering stability and access to nurturing and caring staff members who encourage growth and development through mentoring, academic accountability, and spiritual care.
- The Milton Girls Home houses up to six teen girls at a time and these may be young women who have been through the court system, in and out of multiple foster homes, or simply experienced trauma and/or neglect. In most cases, a typical foster home would be inappropriate for these young women.
- "Embrace Family Preservation" is a program that aims to restore families who are at risk of losing their children by identifying areas of improvement and working toward restoration. Most important when children are at risk of being removed from their families. They will triage and determine how they can help to keep that family together. They have a 96% success rate in keeping families together and also track those families for 3 years following their involvement to ensure that the family remains stable.
- "Embrace Higher Education Home" is a home that provides higher education opportunities for students who have lived in foster care or alternative living arrangements. A group residential living space and support services are provided for students attending UWF and PSC. Goal is to provide debt-free education and the resources and assistance they need to become successful adults.

President Beall adjourned the meeting at 12:52 p.m.
