WEEK IN REVIEW 7/15/2025

At the Rotary meeting, President Hill opened proceedings at 12:05 with John Tice leading the prayer and Pledge of Allegiance. President Hill shared the sad news of Judge Bill Stafford's passing. Judge Stafford, a Pensacola High School and University of Florida graduate, served in the U.S. Army and was appointed as a U.S. District Judge for Northern Florida in 1975. He had been a member of Rotary since that time, having transferred from the Tallahassee club. Hill expressed condolences and asked for prayers for Stafford's family. Funeral arrangements will be shared soon, with a service planned for 1 p.m. next Tuesday at Christ Church.

The meeting continued with the swearing-in of the new board of directors. President Hill expressed confidence in their leadership and their commitment to upholding the values and responsibilities of the Rotary Club of Pensacola. An upcoming naturalization ceremony was also announced, and members were encouraged to contact Chris if interested in attending.

Before the speaker's presentation, the club held its weekly raffle, offering members a chance to win a prize while supporting club activities.

The featured speaker was Chris Plate, Executive Director of FloridaWest Economic Development Alliance. Plate delivered an in-depth presentation on the region's economic development efforts. He explained that FloridaWest plays a dual role—supporting business recruitment, retention, and site development—while also administering incentives and facilitating public-private partnerships through the PEDC. A major theme of his talk focused on product/site development, particularly the lack of ready-to-market industrial properties,

and the organization's active work to prepare sites for new business investment.

Plate highlighted the economic impact of targeted industry marketing, such as recent outreach at international aerospace events in Paris. These efforts have already resulted in five active project leads. He provided data showing nearly 2,500 potential jobs and \$700 million in investment in the pipeline, with notable recent wins from companies like Jupiter Bach, GE Vernova, and National Energy. He emphasized the importance of balancing residential growth with commercial tax base expansion, explaining that industry is needed to offset the cost of public services.

He also detailed the structure of FloridaWest and PEDC, their funding sources, and how they collaborate with state and local governments, utilities, and private investors to drive development. Current priorities include redeveloping Central Commerce Park and preparing land just north of UWF for future industrial use. Plate concluded by reaffirming the organization's commitment to growth and innovation, including initiatives in cyber, Al, and precision manufacturing. He credited partners like the Greater Pensacola Chamber, the University of West Florida, and Florida's Great Northwest for helping support economic momentum in the region.

The meeting wrapped with a note of appreciation for the day's volunteers. Next week's meeting will feature a discussion on childcare policy initiatives led by the Theresa Cserep in the Mayor's office.


