WEEK IN REVIEW 08/30/2016

The weekly meeting of the Rotary Club of Pensacola was held on a sunny Tuesday, August 30, 2016. Dale Jordan and Charlie Sherrill Jr. greeted members and quests at the door. Tim Kane did an outstanding job of ticket sales and Dr. Jimmy Jones was the winner of the \$54 jackpot. President Brian Baumgardner led us in the four way test. Shawn Brantley led us in praver Chris Kelly really and pledge. delivered the Sunshine and welcomed the single guest for the day. Happy Birthday went out Kathy Horton Brown, Milton Usry, Sandra Smith, Bob Benz, Mac Miller, Mike Ferguson and Charles Beall, all long serving Rotarians. De Flounlacker introduced her friend and colleague and Past President Andrea Krieger, President/ CEO of United Way of Escambia County. Andrea provided a fact filled review of the accomplishments and successes of the efforts of United Way of Escambia County for the year ending July 2016. In summary, between June, 2015 and July, 2016, \$3.8M

of giving was leveraged to create a \$14.8M impact that helped 190,000 local citizens. The achievements are a testament to the power of leveraged giving combined with proven programs that work together to solve problems. The United Way of Escambia County has three main focus areas for improving the life in the community: Education, Health and Financial Stability. Programs, such as Cram the Van, Reading Pals, Vista Align, the Dial 2-1-1 and Free Tax Assistance programs are designed to deliver measurable improvements in these areas. Through the combination of generous donations of cash, volunteers and grants the United Way was successful in providing services to assist local families and made significant gains toward improved school readiness, Health and Financial Stability. In the area of Education; donations to ECARE of \$1.00 resulted in a return of \$2.10. The Stay Healthy at Home project vielded a return of \$3.76 for every \$1.00 and the returns for the

Voluntary Tax Assistance Program were \$10.47 for every \$1.00 of giving. Success was measured by a demonstrated 3% increase in Grade Averages for program participants, and an increase in school attendance rates from 44% to 69% and increases in the filing of tax returns resulting in increases in the Earned Income Credit for many families, otherwise left unclaimed. Over the course of the past year 2,774 homeowners were assisted with resolutions to foreclosure or eviction issues. The numbers for the past year tell the story that "The United Way" to Give, Advocate, Volunteer and Live United is improving life for many in Escambia County thanks to the good work of the Staff. Volunteers and Partners of United President Brian thanked all Wav. who served and the meeting was adiourned.
