Another day....another chance to explore the community of Pensacola and the power of Rotary to create hope and magic in it. Those who skipped by the raffle table were warmly greeted by Lesie Mickles and Clark Merritt. For others, the lure of a big payday and the enticing words of Chuck Michaels and Lori NeSmith were too much and they bought in chance.

The food was great and the company was greater. As we began the meal, our illustrious president, Charles Beall, lead us in the 4 Way test while our President elect, Henry Roberts lead us in the opening prayer. The it was time for the musical stylings of the world famous Rotary Rooters! The Raffle drawing yielded the winner \$10 and each of us another opportunity to strike it rich next week.

Lesie Mickles and Five Flags Rotary gave an incredible update on the summer book program collaboration with the Early Learning Coalition and we presented the ELC with a check for \$10,000 to help further the work of the ELC and provide for 1,700 new readers in Escambia County. Sarah Horn delighted us with Sunshine and then Ed Wonders present our speaker for the day, Michael Bodenhausen.

Michael Bodenhausen is currently the CEO of YMCA of Northwest Florida. His background includes over 40 years of extensive YMCA experience with five different associations involving four states. Michael has experience in program development, capital development, volunteer and staff development, membership, retention, fundraising, community relations, and other aspects of the YMCA management.

The YMCA entered into a partnership with the City of Pensacola to reduce redundancy in services. The YMCA exchanged land and a building for the Vickery Center, allowing the City to handle basketball and soccer programs, while the YMCA focused on after-school and day camp programs. The YMCA now runs 13 licensed after-school sites, with 40% of the children receiving scholarships. The YMCA also manages the City's pools at Roger Scott and Cecil T Hunter, saving the City \$40,000 in a single summer.

The YMCA collaborates with 27 non-profit organizations in the community. It provides swimming lessons to children from the Boys and Girls Club and supports the placement of foster children through Lakeview Center by offering after-school program slots. The YMCA also works with the Satori Club to teach swimming to group home residents and provide sailing and employment opportunities. Additionally, the YMCA partners with Home Base, a new veteran program, to help integrate veterans with PTSD back into society.

The YMCA has a rich history dating back to 1880, when it taught English as a second language, ran the library, and served as the first blood bank in Pensacola. The YMCA's New World's Reading Initiative provides free books monthly to children from kindergarten through fifth grade, aiming to improve literacy. The YMCA REACH program, supported by the Escambia Trust Fund, has shown significant improvements in reading scores for participating students using phonics-based instruction.
