Guest Speaker: Lindsey Cannon from Escambia Children's Trust

Our guest speaker was **Lindsey Cannon**, the Director for the Escambia Children's Trust (ECT). Lindsey provided a detailed overview of ECT's mission and goals.

The ECT was established four years ago through a local referendum to help children by funding new projects and initiatives using special district taxes. The organization is governed by a 10-person board, with five members appointed by the governor, and a professional staff.

Lindsey highlighted the transparent nature of the ECT's operations, noting that their public meetings and annual audits are available for anyone to view online. Their administrative costs average just 5%, and they currently have 35 active contracts with various organizations that serve over 5,000 children.

She addressed a common question regarding their funding: why so much goes to labor costs? Lindsey explained that most projects are very "manpower intensive," requiring qualified and screened personnel who work directly with children.

Lindsey wrapped up her talk by mentioning that the ECT is in the middle of executing its five-year plan. The organization aims to fill educational gaps for children as county funding may be cut and is actively working to enhance community involvement. Finally, she encouraged anyone interested in becoming a proposal reviewer or joining a focus group to get involved.

The meeting concluded after a brief Q&A session.
